*The Centers for Medicare & Medicaid Services (CMS) recently issued a rule  
(frozen) that will improve the electronic exchange of healthcare data among  
payers, providers, and patients. The CMS rule will streamline processes related  
to prior authorization with the goal of reducing the burden on providers and  
patients. Medicaid, CHIP (Children’s Health Insurance Program), and QHP*

*(Qualified Health Plan) payers will be required to build and implement FHIR-enabled APIs that will:*

- *Allow providers to know, in advance, what documentation would be needed for each different payer*
- *Streamline the documentation process*
- *Enable providers to send prior authorization requests (and receive responses electronically) directly from the provider's EHR or other practice management system*

**Policy Solutions to Improve Health Data Exchange**

*The COVID-19 pandemic has highlighted the gaps in the US public health infrastructure and the inconsistencies in data received by state and local health departments. These deficiencies have resulted in an over-reliance on faxes, phone calls, and other manual reporting means, often resulting in missing data. Manual methods and incomplete data create additional burden on providers and has slowed the ability of public health officials to identify hotspots, perform crucial outreach, and inform reopening decisions. This presentation will review challenges related to four use cases within public health data exchange—vaccine data, lab reporting, case reporting, and syndromic surveillance—and potential policy recommendations to improve the collection and exchange of data.*
